Irving Park Metra	<p>Ed B. reported that he spoke at the city budget hearing in August, which led to contacts by representatives from the CTA and the Mayor's of the People with Disabilities. The CTA representative seemed interested in the connection that the Irving Metra station could make for all the other CTA train and Metra train lines with Irving stops.</p> <p>Joe A. said the association should urge the CTA to have the 80X Express route bus terminate at Wrigley Field during the Cubs season.
