# **Six Cornucopia Vendor Rules, Regulations and Info**

- **Please note: This event is an OUTDOOR sidewalk bazaar.**
- **Set-up time: 9 a.m., Sept. 19, 2008. No assistance will be available for loading or unloading.**
- **Bazaar begins at 11 a.m. and ends at 5 p.m.**
- **Vendors must furnish their own tables, chairs and displays. The location does not afford protection from rain and vendors should plan accordingly.**
- **Tents are allowed on the sidewalk. No signs may be attached to buildings.**
- **Vendors are responsible for the removal of all garbage from their spaces.**
- **Electricity is NOT available.**
- **Refunds will not be issued in the event of rain, any weather condition or for any other reason.**
- **Six Corners will not be responsible for any loss, theft, damage, or defacement of the property of any vendor.**
- **All vendors will be responsible for following state and/or federal tax regulations.**
